In 2016, Woodside was established in Senegal with a small team who laid the foundations of a vibrant country office supporting in country activities for the Sangomar Field Development

The role of the Woodside team in Senegal, is to support key activities including government and stakeholder engagement, finance, legal and other key activities which will support the development and operations of the Sangomar project. The local team is comprised of eight Senegalese nationals and three Australians, along with 30 service providers who supports the day to day activities of Woodside in Senegal.

The Country Manager for Senegal is David Grislain and his role is to manage Woodside's activities in Senegal and establish a

dynamic, professional local team to support the Sangomar Field Development. "The success for the Sangomar Development will be our local Senegalese workforce and this team will grow as activities increase. The team is vital to the Woodside's success. We are currently implementing regular training programs for our staff based on Woodside approach to learning and development, which is 70% on the job training, 20% relationships including mentoring and 10% formal education. This training is delivered in Dakar but also through trips to our headquarters in Australia," said David.

Woodside is committed to providing opportunities for the Senegalese nationals on the Sangomar Field Development, and is working with the Government of Senegal, contractors and industry partners to enable these opportunities.

SANGOMAR FIELD DEVELOPMENT COMMUNITY UPDATE

Welcome to the first Sangomar Field Development community update. The community update provides Woodside an opportunity to inform the community of the latest activities occurring in Senegal to support the Sangomar Field Development, Senegal's first offshore oil development.

The Sangomar Field Development is Approved

In January 2020, Woodside and its joint venture partners made the final investment decision (FID) for the first phase of the Sangomar Field Development which is targeting to be Senegal's first offshore oil development. The FID decision initiated the execution phase of the project, which will include the drilling of the 23 subsea wells, the commencement of the construction of the offshore infrastructure with the commencement of production from Sangomar oil reservoirs in 2023.

On 14 January, a ceremony was held in Dakar in the presence of the Minister of Petroleum and Energies, Mouhamadou Makhtar Cisse, and other senior Ministry officials to witness the signing of the FID statement by the joint-venture, following execution of key contracts and agreements a few days earlier. Woodside also hosted a celebration with more than 100 representatives of the Government of Senegal, the diplomatic corps, industry and civil society in attendance to celebrate this historical milestone in the development of the oil and gas industry in Senegal.

As part of taking FID, Woodside awarded a series of key contracts for the Sangomar Field Development including a purchase contract

for the FPSO facility with Modec Inc; the subsea construction and installation contract with Subsea Integration Alliance (SIA); and the drill rig contract with Diamond Offshore. These contractors among others have commenced the final engineering and preparations for the project. In light of the impacts of COVID-19, Woodside has taken early steps to proactively manage the emerging impacts of the pandemic on the supply chain and project schedule and is working with contractors, the Government of Senegal and the joint venture.

Through 2020, Woodside will continue to progress key activities in Senegal for the Sangomar Field Development, including the establishment of a marine supply base at the Port of Dakar and supporting key contractors with their local employment, regulatory permitting and procurement activities in anticipation of drilling and installation of project infrastructure commencing in 2021.

The first phase of the Sangomar Field Development will support more than 20 years of oil production, providing billions of dollars of revenue for Senegal through government payments and through Petrosen as joint venture participant in the project.

The seismic survey is complete

In February 2020, Woodside completed a marine seismic survey of the Sangomar Field and other surrounding oil and gas fields. The survey was undertaken in two phases between July 2019 through to November 2019 and in February 2020. It covered an area of approximately 2300km² which is nearly 28 times the size of Dakar. The seismic survey will provide a better understanding of the geology and reservoirs to support the development of the Sangomar Field.

In preparation for the seismic survey, a series of stakeholder engagement activities were held with fishing and other community stakeholders across the Dakar, Thies and Fatick regions. This engagement informed stakeholders of the planned marine survey and also provided them with vital safety information and details of the mitigation measures to minimise impacts on fishing activities in the area of the survey. A majority of the artisanal fishing associations, fishing quays and communities along the Petite Cote between

The Gambia and Dakar were engaged by Woodside prior and during the seismic survey to seek their feedback and address their questions on the activity.

Following feedback from stakeholders, Woodside implemented a wide range of engagement techniques including the distribution of fact sheets and posters, an extensive radio campaign, Senegalese fishing liaison officers (FLOs) aboard guard vessels at sea and daily activity look ahead and updates issued via WhatsApp. Woodside also engaged town criers at busy fishing quays of the Thies and Dakar areas to provide regular updates to fishermen when the survey was close the coast. During the survey more than 500 fishermen were engaged at sea and close to 100 enquires were received by Woodside.

Woodside would like to thank the CLPAs and the wider fishing community for their support for the safe operation of the marine survey.



Contribution to the Senegal COVID-19 Fund

At Woodside, we are committed to getting through the COVID-19 pandemic by supporting our people, our suppliers and local communities where we operate.

In Senegal, Woodside has donated US\$50,000 to the COVID-19 Fund established by Government of Senegal. This donation is part of Woodside's broader COVID-19 community fund supporting our communities in Australia and around the world.

Woodside remains committed to delivering long-term economic and social benefits for neighbouring communities of the Sangomar Field Development and to Senegal. We continue to build upon existing support for social investments programs, community events and capacity building initiatives for the Government of Senegal.

Maximising local content

Woodside is committed to maximising local content for Senegal from the Sangomar Field Development.

In 2017, Woodside supported the foundation of Invest in Africa (IIA) in Senegal, a not-for-profit organisation that supports small and medium enterprises (SME) across Africa gain access opportunities to tender and engage in the supply chain of the oil and gas industry. In collaboration with IIA, Woodside has actively engaged local SMEs through seminars and workshops to help them prepare for the upcoming procurement activities for the Sangomar Field Development contractors.

On 5 March 2020, IIA and Subsea Integration Alliance (SIA), the contractor responsible for the subsea infrastructure on the Sangomar Field Development hosted a workshop briefing for over 150 local SMEs on the procurement opportunities with their scopes of work in Senegal. The event also provided an opportunity for these businesses to network and meet with the SIA, IIA and Woodside teams.

This event the first of many supplier briefings for the Sangomar Development and with the continued support for IIA, Woodside is expecting to have a high level of participation of the Senegalese SMEs throughout the project's local supply chain.



Supporting the growth of INPG

Woodside has been working closely with the National Institute of Oil and Gas (INPG) to help educate and grow a local professional and skilled Senegalese workforce ready to support the Sangomar Field Development and the growing oil and gas industry in Senegal.

Support to date includes providing computers, high-tech teaching equipment and industry-leading oil and gas education materials to support the INPG Master's Program. Funding was also provided to develop a business plan for INPG, which was undertaken by a

leading international independent consultancy. The business plan was developed in consultation with INPG and sets a road map for the development of a world-class training institute for West Africa.

Woodside is committed to supporting INPG and is working on its next tranche of support for the Institute help develop locally skilled oil and gas workforce to participate in the growing oil and gas industry in Senegal.
