Woodside recognises that a key contributor to our success is an inclusive culture that promotes diversity and a sense of belonging. Our Inclusion and Diversity Policy outlines our commitment to an inclusive workplace culture that values diversity and promotes equal opportunities.

Woodside aims to drive inclusion and diversity by, among other things:

- Respecting the unique attributes that each individual brings to the workplace and fostering an inclusive values-led culture;
- Providing diversity education and training as well as undertaking diversity initiatives and measuring their effectiveness;
- The Board approving and reviewing progress against Woodside's Inclusion and Gender Diversity Strategy;
- The Board annually reviewing the measurable objectives it has set for achieving improvement in Woodside's diversity mix and the progress in achieving those objectives.

In 2017 we advanced our strategy to drive sustainable improvements in gender diversity at all levels of the workforce. Female representation remains steady, 29% versus 28.4% in 2016, significantly higher than the industry average of 22% (The World Petroleum Council and The Boston Consulting Group, 2017). Voluntary turnover of women is 4.5% and return rates from parental leave is 95%, which is our highest rate recorded. Executive and senior female representation have continued to increase since 2016 from 19.6% to 23.9% and 15.9% to 17/6% respectively.

We continue to build our female talent pool through our development programs. Our Production Training Academy continues to develop our female trainees and apprentices. The 2017 intake was 40% women. The overall percentage of offers and acceptances for the 2018 graduate development program for women was 50%.

In 2018, Woodside has commenced a three year strategy to continue driving Inclusion and Gender Diversity across all levels of the organisation. The Gender Equality Matters employee networks support the strategy by delivering agreed activities, enabling personal action for men and women and promoting awareness of gender equality.
